APEX Analytix® software, is marketed and sold under the brand name FirstStrike®. The core application is available in a version for companies who manufacture goods and provide services and in a

version for retail companies. The fundamental function of FirstStrike® is overpayment detection and reporting. FirstStrike® also includes management reporting, continuous monitoring for potential vendor fraud, and inquiries and reports for tracking A/P metrics, cash management, vendor analysis, spend analysis, diversity tracking, and contract compliance. APEX Analytix® software applications also include FirstStrike® Fraud Detect, FirstStrike® Vendor Portal vendor self-service and FirstStrike™ Decision Metrics dashboard of real-time metrics.

APEX Analytix® currently provides audit services to companies in industrial manufacturing, telecommunications, technology manufacturing, pharmaceuticals, financial services, grocery, transportation, general merchandise, energy, banking, and others. Primarily providing audits to recover overpayments in accounts payable, APEX Analytix® also has dedicated and staffed functions to conduct sales and use tax audits, freight audits, statement reviews and escheatment audits.

The company has approximately 220 active clients with 52 of these companies also using FirstStrike® software. The majority of the combined audit and software clients are using FirstStrike® to proactively identify errors and engaging APEX Analytix® as the primary accounts payable auditor to capture any overpayments that are not being detected by FirstStrike®.
